**COUNT 1:** In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **JAMES EDWARD JOHNSON** with the offense of **AGGRAVATED ASSAULT** for that the said **JAMES EDWARD JOHNSON** on the 28th day of July, 2022, in the County aforesaid, did knowingly make an assault upon the person of Jennifer Baum with an object, a device, and an instrument which when used offensively against a person is likely to result in serious bodily injury and did result in serious bodily injury by grabbing Jennifer Baum by the neck and squeezing rendering Jennifer Baum incapable of breathing and hitting Jennifer Baum's head against a wall, said person and the accused not being siblings but were at the time of the offense living in the same household; in violation of O.C.G.A. § 16-5-21, Contrary to the laws of said State.

**COUNT 2:** In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **JAMES EDWARD JOHNSON** with the offense of **FALSE IMPRISONMENT** for that the said **JAMES EDWARD JOHNSON** on the 28th day of July, 2022, in the County aforesaid, in violation of the personal liberty of Jennifer Baum, did unlawfully arrest, confine, and detain Jennifer Baum without legal authority; in violation of O.C.G.A. § 16-5-41, Contrary to the laws of said State.
