COUNT 1: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse NIGEL BURKE BROWN with the offense of RAPE for that the said NIGEL BURKE BROWN, on the 4th day of June 2022, in the County aforesaid, did have carnal knowledge of **REDACTED** a female, forcibly and against her will; in violation of O.C.G.A. § 16-6-1, Contrary to the laws of said State.

COUNT 2: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse NIGEL BURKE BROWN with the offense of FALSE IMPRISONMENT for that the said NIGEL BURKE BROWN, on the 4th day of June 2022, in the County aforesaid, in violation of the personal liberty of Faith Ann Carter, did unlawfully confine **REDACTED**, without legal authority by refusing to let Faith Ann Carter leave his bathroom; in violation of O.C.G.A. § 16-5-41, Contrary to the laws of said State.

COUNT 3: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse NIGEL BURKE BROWN with the offense of AGGRAVATED SODOMY for that the said NIGEL BURKE BROWN, on the 4th day of June 2022, in the County aforesaid, did perform a sexual act with the person of **REDACTED** involving the sex organs of the accused and the mouth of said person, said act having been performed with force and against the will of said person, by forcing his penis into her mouth against her will; in violation of O.C.G.A. § 16-6-2(a)(2), Contrary to the laws of said State.

COUNT 4: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse NIGEL BURKE BROWN with the offense of CRIMINAL TRESPASS for that the said NIGEL BURKE BROWN, on the 4th day of June 2022, in the County aforesaid, did intentionally damage a cell phone, the property of **REDACTED** without her consent, by puncturing said cell phone with a knife rendering it unusable, said damage being less than \$500.00; in violation of O.C.G.A. § 16-7-21(a).

Contrary to the laws of said State, the good order, peace and dignity thereof.
