COUNT 1: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **HENRY GREG THOMAS, JR.** with the offense of **AGGRAVATED BATTERY** for that the said **HENRY GREG THOMAS, JR.** on the 11th day of September, 2020, in the County aforesaid, did maliciously cause bodily harm to Lawayne Banks by depriving said person of normal use of said person's leg, a member of said person's body, by shooting said person in said leg; in violation of O.C.G.A. § 16-5-24, Contrary to the laws of said State.

COUNT 2: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **HENRY GREG THOMAS, JR.** with the offense of **AGGRAVATED ASSAULT** for that the said **HENRY GREG THOMAS, JR.** on the 11th day of September, 2020, in the County aforesaid, did make an assault upon the person of Lawayne Banks with a deadly weapon, by pointing a semi-automatic handgun at said person; in violation of O.C.G.A. § 16-5-21, Contrary to the laws of said State.

COUNT 3: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **HENRY GREG THOMAS, JR.** with the offense of **POSSESSION OF FIREARM BY CONVICTED FELON** for that the said **HENRY GREG THOMAS, JR.** on the 11th day of September, 2020, in the County aforesaid, did knowingly and without lawful authority, possess a semi-automatic handgun, a firearm; accused having been convicted of a felony, in the Superior Court of Jackson County on 08/09/2002 for the offense of entering an automobile with the intent to commit a theft therein; in violation of O.C.G.A. § 16-11-131(b), Contrary to the laws of said State.

COUNT 4: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **HENRY GREG THOMAS, JR.** with the offense of **SIMPLE BATTERY** for that the said **HENRY GREG THOMAS, JR.** on the 15th day of September, 2020, in the County aforesaid, did intentionally make physical contact of an insulting or provoking nature, to wit: to the person of Officer Seth Jones, said person being a police officer engaged in carrying out his official duties by spitting in said person's face; in violation of O.C.G.A. § 16-5-23,

Contrary to the laws of said State, the good order, peace and dignity thereof.
