Dear Chief Judge Norris,

As reported at the July 15, 2022, Judicial Workload Assessment Committee meeting, your circuit's judge workload value is below 0.9. As a result, I'd like to invite you to the November 18 JWAC meeting to share any challenges your circuit may be experiencing that adversely impact your case count. If the circuit's value remains below the 0.9 threshold for the next two years, the JWAC—pursuant to Judicial Council policy—may make a recommendation to the Judicial Council regarding the judicial resources in your circuit in 2024. If you believe that there are any problems with your circuit's case count not caused by below average caseload, we want to know about that. It is my sincere desire to help your circuit overcome any data challenges that you may be experiencing. Having experienced some data issues with my own clerk of

court in the past, I can assure you that I will be sympathetic with your challenges. I also believe that if that is the case, we need to be working on it now, not in 2024.

I look forward to seeing you on November 18, 2022. In the interim, the AOC Research staff is available to assist you and the clerk's office with troubleshooting some of the case count reporting issues outlined in the attached letter. Dear Ms. Gonzalez:

We write to seek your leadership, involvement, and direct participation in Court activities for the matters assigned to your office. Over the course of 2022, we have become increasingly concerned regarding the efficacy, preparation, and procedural readiness of Assistant District Attorneys working in our four courts. Each of us has emphasized the needs listed below to the ADAs working in our courts, yet the issues remain.

The matters we find most in need of your direct intervention and assistance are as follows:

- Offering pleas in a timely manner
- Providing discovery in full and in a timely manner
- Securing witnesses for trials and hearings
- Coordinating with law enforcement in advance of hearings and trials
- Providing witness lists at arraignment and supplementing said lists in advance of trial
- Recommending citizens who are charged with possession to the appropriate Accountability Court to lower recidivism
- Trying or otherwise resolving cases previously accused under the now repealed O.C.G.A § 17-7-70.1(a.1) before the sunset provision occurred on June 30, 2022
- Utilizing the grand jury to its full potential since functions resumed in March 2021
- Filing of accusations in Oconee County
- Filing of CHINS petitions in Juvenile Court pursuant to O.C.G.A § 15-11-140

With so many cases waiting to be tried, it is imperative that the Court not be further delayed by the State's lack of preparation and/or failure to follow proper procedures. We understand that ADA staffing issues and high turn-over rates have created additional stresses and difficulties for the remaining attorneys who are already handling such large caseloads. With that in mind, we must all work together to move cases toward their just resolution with timeliness and accuracy.

Therefore, we remind you of O.C.G.A. § 15-18-6, specifically (1) & (2) which states:


*The duties of the district attorneys within their respective circuits are:*

- (1) To attend each session of the superior courts unless excused by the judge thereof and to remain until the business of the state is disposed of;*
- (2) To attend on the grand juries, advise them in relation to matters of law, and swear and examine witnesses before them;*

We expect for you to directly participate and appear for sessions of criminal arraignments, final pleas, jury trials, grand jury, and motion hearings. This will aid in several important areas. First, it will allow you to see the scope of the matters discussed and, should an issue arise, address and resolve such matters at the earliest possibility. Secondly, because of staffing issues, your direct participation will help ease the load on the ADAs and help us move the backlogged cases.

We look forward to your assistance and participation. If you have any questions, please feel free to set up a meeting with the four of us.


