matter.



ADMINISTRATIVE ORDER

BY THE EXECUTIVE DIRECTOR:

ORDERED: That under the authority contained in O.C.G.A. § 15-18-5, Randy McGinley, District Attorney, Alcovy Judicial Circuit, or his designee, is hereby appointed to act as District Attorney Pro Tempore, Western Judicial Circuit, to prosecute in the name of the State, for the time period beginning from investigation, arrest or Grand Jury proceedings, whichever comes first, until all appeals are exhausted, the following case, to wit: State of Georgia v. 
