COUNT 2: In the name and on behalf of the citizens of the State of Georgia, do hereby charge and accuse **TYLER LAMIR RIDGEWAY** with the offense of **ARMED ROBBERY** for that the said **TYLER LAMIR RIDGEWAY** on the 16th day of February, 2023, in the County aforesaid, with the intent to commit a theft, did unlawfully take US Currency, property of Dexter King, from the immediate presence of of Dexter King, by the use of a handgun, an offensive weapon; in violation of O.C.G.A. § 16-8-41, Contrary to the laws of said State.
